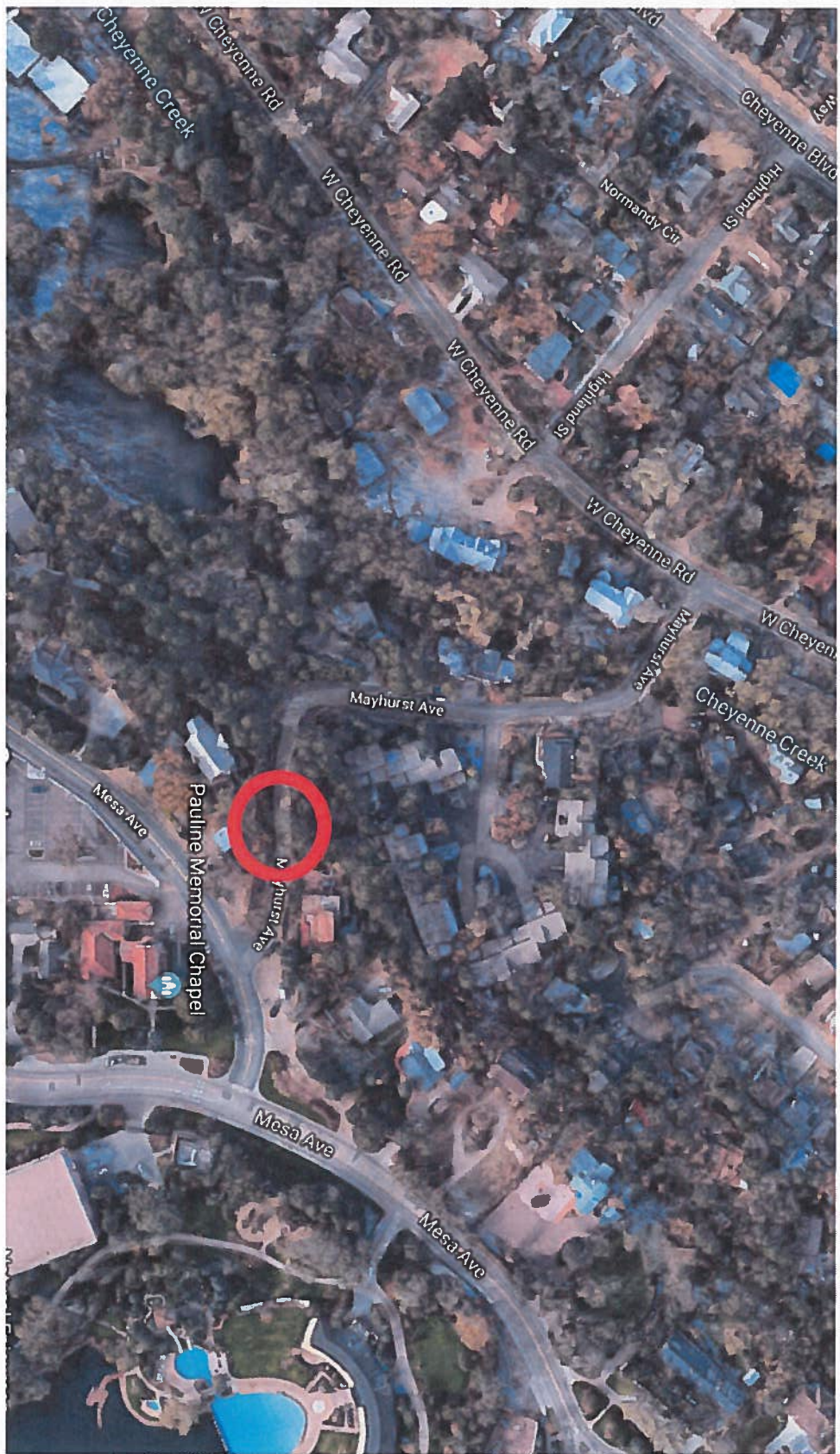

A study of vehicle traffic was conducted with the device having serial number 402349. The study was done in the NB lane at Mayhurst N of Mesa in Colorado Springs, CO in El Paso county. The study began on 06/27/2019 at 12:00 AM and concluded on 06/28/2019 at 12:00 AM, lasting a total of 24.00 hours. Traffic statistics were recorded in 15 minute time periods. The total recorded volume showed 444 vehicles passed through the location with a peak volume of 20 on 06/27/2019 at [05:45 PM-06:00 PM] and a minimum volume of 0 on 06/27/2019 at [09:45 PM-10:00 PM]. The AADT count for this study was 444.

SPEED

Chart 1 lists the values of the speed bins and the total traffic volume for each bin. At least half the vehicles were traveling in the 20 - 25 MPH range or lower. The average speed for all classified vehicles was 23 MPH with 79.00% vehicles exceeding the posted speed of 20 MPH. 1.50% percent of the total vehicles were traveling in excess of 55 MPH. The mode speed for this traffic study was 20MPH and the 85th percentile was 27.18 MPH.

Chart 2 lists the values of the classification bins and the total traffic volume accumulated for each bin. Most of the vehicles classified during the study were Vans & Pickups. The number of Passenger Vehicles in the study was 174 which represents 44 percent of the total classified vehicles. The number of Vans & Pickups in the study was 178 which represents 45 percent of the total classified vehicles. The number of Busses & Trucks in the study was 28 which represents 7 percent of the total classified vehicles. The number of Tractor Trailers in the study was 19 which represents 5 percent of the total classified vehicles.
