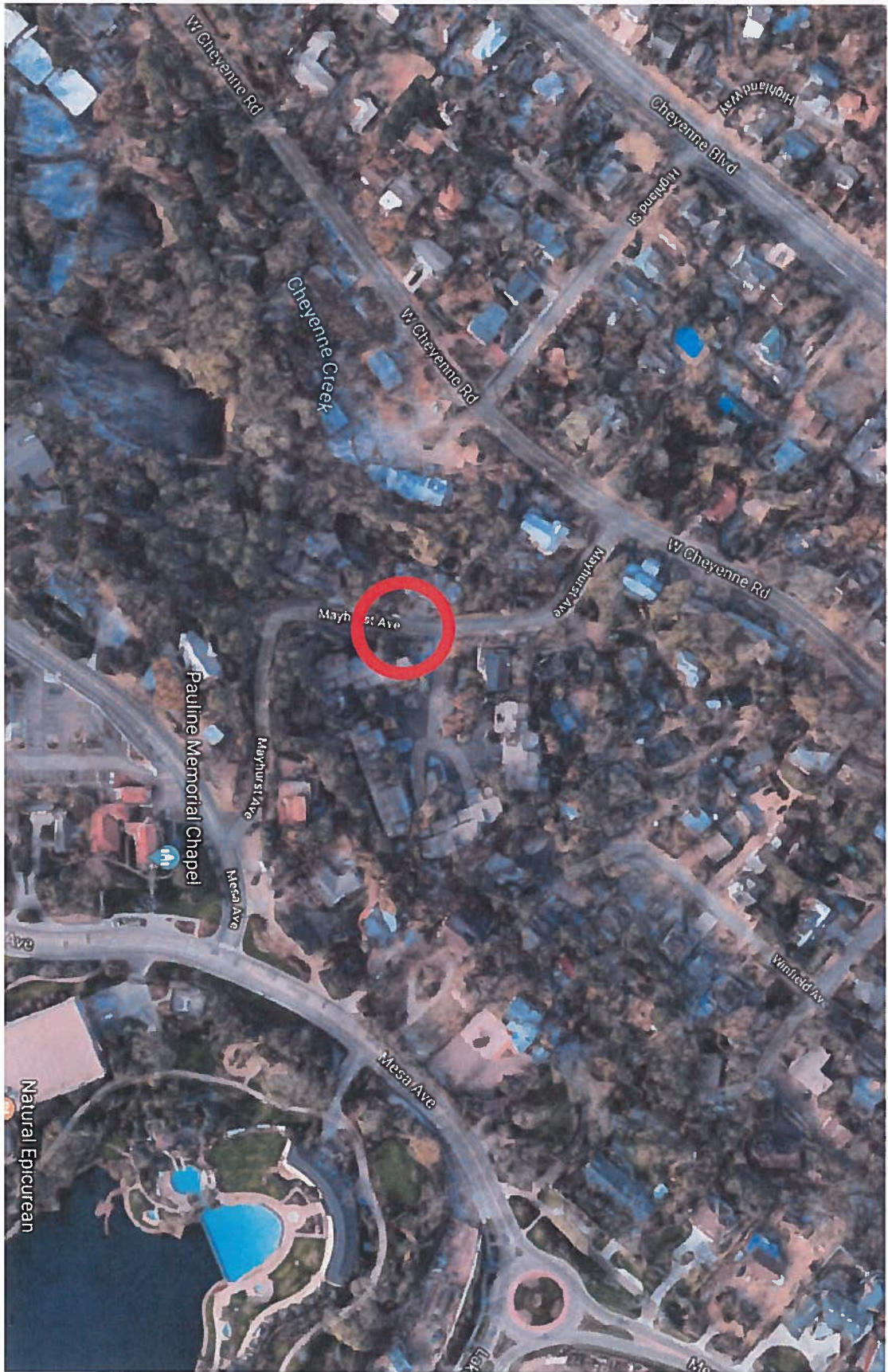

A study of vehicle traffic was conducted with the device having serial number 402811. The study was done in the NB lane at Mayhurst S of Cheyenne in Colorado Springs, CO in El Paso county. The study began on 08/22/2019 at 12:00 AM and concluded on 08/23/2019 at 12:00 AM, lasting a total of 24.00 hours. Traffic statistics were recorded in 15 minute time periods. The total recorded volume showed 244 vehicles passed through the location with a peak volume of 17 on 08/22/2019 at [07:00 AM-07:15 AM] and a minimum volume of 0 on 08/22/2019 at [01:15 PM-01:30 PM]. The AADT count for this study was 244.

SPEED

Chart 1 lists the values of the speed bins and the total traffic volume for each bin. At least half the vehicles were traveling in the 20 - 25 MPH range or lower. The average speed for all classified vehicles was 20 MPH with 52.74% vehicles exceeding the posted speed of 20 MPH. 0.00% percent of the total vehicles were traveling in excess of 55 MPH. The mode speed for this traffic study was 20MPH and the 85th percentile was 24.49 MPH.

Chart 2 lists the values of the classification bins and the total traffic volume accumulated for each bin. Most of the vehicles classified during the study were Passenger Vehicles. The number of Passenger Vehicles in the study was 148 which represents 62 percent of the total classified vehicles. The number of Vans & Pickups in the study was 82 which represents 35 percent of the total classified vehicles. The number of Busses & Trucks in the study was 5 which represents 2 percent of the total classified vehicles. The number of Tractor Trailers in the study was 2 which represents 1 percent of the total classified vehicles.
